It is to inform that a Show Cause Notice was issued on 21.08.2017 to M/s Green Fields Exports and others wherein it is alleged that M/s Green Fields Exports had attempted to export the impugned goods by grossly inflating the price for claiming higher drawback fraudulently. Confiscation of the impugned goods under Section 113(i) and 113(ii) of the Customs Act, 1962 was proposed in the SCN.



Therefore, the SCNs were affixed on the Notice Board of GST Bhavan, Basheerbagh, Hyderabad and ICD/ CFS, Sanathnagar, Hyderabad in terms of Section 153(b) of Customs Act, 1962.
