Sub: Customs - Smuggling of Foreign Origin Cigarettes by M/s.Mounika Industry, Mahabubnagar - Extension of time limit for issuance of Show Cause Notice in terms of Section 110 (2) of Customs Act, 1962 - Reg.



Acting on specific intelligence that M/s Mounika Industry, Mahabubnagar District, (IEC 0914017471) were attempting to import prohibited goods i.e., Foreign made Cigarettes into India by concealing the same in a consignment declared as 'BOPP Self-Adhesive Tapes' stuffed in a container bearing No.MRKU 3189545 (40 feet) through the ICD, Thimmapur, Ranga Reddy District, the Officers of DRI, Hyderabad Zonal Unit examined the said container on 01-12-2017 and found the cigarettes have been imported in violation of the provisions under the CA,1962 and other Acts. Hence, the Officers of DRI seized the "Tapeco BOPP Self-Adhesive tapes" and cigarettes contained in the said container under panchanama dt 01.12.2017.

2. In this regard, the DRI, Hyderabad had sought for extension of time limit for issuance of notice in terms of Section 110 (2) of the Customs Act, 1962 read with Section 124 of the Customs Act, 1962, as the investigation could not be completed within the prescribed time limit of six months from the date of seizure i.e. 01.12.2017. I have examined the matter and find that the grounds for extension of time limit are justified.

3. In view of the above, it is to inform that the undersigned, in terms of powers conferred under Section 110(2) of the Customs Act,1962, has extended the time limit for issuance of Show Cause Notice for a further period of six months from the due date i.e. 31.05.2018.
