Sub:- Monitoring realization of export proceeds in EDI under the BRC Module for ICES (Introduced in year 2009) and the new RBI BRC Module introduced in 2014 - Reg.

The Exporters and Customs Brokers operating through the ports situated in Hyderabad Customs Commissionerate (viz. Air Cargo Complex/ ICD-Sanathnagar/ ICD-Thimmapur) are hereby informed that RBI BRC module has been introduced in ICES and as a result of this the details of Foreign Exchange Realization data in respect of shipping bills with LEO date from 01.04.2014 onwards is available in RBI BRC Module.

For the period 01.04.2013 to 31.03.2014 all the exporters and Customs Brokers are hereby informed that they are required to submit Bank Realisation Certificates (BRCs) shipping bill wise or Certificates obtained from Authorized Dealer/ Chartered Accountants that no foreign exchange is pending realization for the exports made by them during a specified six monthly period in respect of the Drawback EDI Shipping Bills with LEO date between 01.04.2013 and 31.03.2014 and exports made through Air Cargo Complex/ ICD-Sanathnagar/ ICD-Thimmapur. These Certificates shall be submitted to the Nodal Officers mentioned against the name of the port in the table given below, **not later than 27.01.2016.**
