
In continuation to the earlier Public Notices issued by this office, attention is also drawn to the following note:

In view of the pendency of the IGST Refund claims owing to the errors like mismatch of the invoice numbers , Shipping Bill Numbers, Account Numbers not mentioned and Non closure of the EGM at the Gateway port etc., the Trade is hereby informed that a Special Drive for clearance of all such pending IGST Refund Claims is being undertaken. In this regard "Export Refunds fortnight" is being observed from 15th to 29th March, 2018, where exclusive refund cells have been set up in ICD-Sanathnagar and Air Cargo Complex, Shamshabad to deal with the cases of pending export related refund claims. In view of this all the exporters whose refund claims are pending are hereby requested to approach the following officers in person to get their claims processed. A special appeal is also made to the Exporters Association to inform all the members to avail the facility and get the refund claims processed.
